Guidelines for Submission of Research Papers

Author(s) are invited to contribute their research papers, articles and recent case studies on the themes and sub-themes on "Banking and Financial Services in Indian Economy - Post Demonetization" for presentation in the National Seminar. Contributions should represent original research work/original theory which has not been published or submitted for publication elsewhere.

- 1. Manuscript must be in MS Word Processor in Times New Roman 12 pt. font size with 1" margin from all sides with 1.5 line spacing and papers should be submitted as electronic attachments in Microsoft Word.
- 2. Selection of papers would be based on an abstract of about 250-300 words with key words. Abstracts must include a clear indication of the purpose of research, methodology, major results, implications and key references. The author(s) should clearly mention under what area of interest of the conference the paper is to be included. The maximum number limit of authors for a paper is two.
- 3. The cover page of the abstract should contain: Title of the paper, name of author(s), affiliation details, and address for correspondence with e-mail and telephone number(s).
- 4. The length of full paper should be limited to approximately 4500 words (as per the specified layout) excluding tables and figures.
